September	August	February
<p><b>Have the “college” talk with your parents</b> Where do you want to go? What major? <p><b>Consider how you’ll pay for college</b> Take a look at different types of loans and scholarships. From the exceptionally tall to the llama enthusiast, there’s a scholarship opportunity for everyone!</p>	<p><b>Submit your FAFSA</b> Some student aid programs award funds on a first-come, first-served basis so don’t wait too long to submit your FAFSA. <b>Consider re-taking standardized tests.</b> You can also re-take your SAT to try to raise your score.</p>	<p><b>Decision time!</b> After deciding where you’d like to go, make sure to stay on top of communications from your school. Deposits, forms, and housing apps are all due prior to leaving in the fall.</p>

<p><b>Take the ACT/SAT</b> These tests are crucial to figuring out which schools are a good match for you. Be sure to take practice tests and even a prep course to ensure that you get your best score possible.</p>	<p><b>Stay on top of deadlines</b> Don’t let the date for early application sneak up on you. Many schools have different application deadlines; make sure you know when everything is due.</p>	<p><b>Make a budget</b> Talk with your parents to figure out how much you’ll expect to earn and pay while at school. Having a budget will start you on the journey toward financial responsibility.</p>
March	January	Summer
<p><b>Make a file for each school</b> Check out college fairs and visit campuses. Then compare information about each school’s academics, financial aid, and campus life.</p>	<p><b>Apps are due!</b> January 1st is the universal deadline for most schools’ applications, so make sure yours are in. If you applied early action, you could get your decision letter any day.</p>	<p><b>Final to-do items</b> This is the time to attend orientation, register for your classes, and make sure the tuition bill is paid. It’s also the time to have fun so have an amazing time!</p>
